Summary

The Nebraska Section of the Institute of Transportation Engineers (NITE), a section of the Missouri Valley District of ITE (MOVITE), celebrated its first year as a section in 2021. Through the leadership of our president, Garret Menard, the NITE Board continued navigating the process of elevating NITE from a chapter to a section as part of the ONE ITE initiative. Starting in 2021, the LOCATE Chapter became the Nebraska Section of ITE (NITE) with geographic boundaries including the entire state of Nebraska and the Iowa counties of Harrison, Mills, and Pottawattamie. Throughout this transition, the NITE section continued its commitment to providing professional development opportunities for public and private sector transportation professionals in the Nebraska Section Geographic area as well as continued support of the DriveSmart program.

The year was again a challenging year for any organization to conduct meetings and events due to the COVID-19 pandemic. With the continuing pandemic, NITE carried over the practice from 2020 of holding virtual meetings. Following guidance from local health officials NITE was able to resume in-person meetings later in the year.

Membership

Section membership remained almost the same compared to 2020 with 104 paid members in 2021 and 105 in 2020. In 2021 most of the general meetings were held virtually which contributed to higher attendance than in person meetings. Moving forward, NITE will explore conducting hybrid meetings in the future to help increase attendance. In previous years, the LOCATE chapter began alternating location of the Transportation Student Meet & Greet between UNO and UNL to encourage participation of students from both universities. However, these events were not held in 2021 due to the ongoing pandemic. As of December 31, 2021, NITE had a total of 104 paid members.

Activities

The 2021 Section calendar was filled with a variety of technical and social events. NITE held five general meetings (including the annual meeting), and held an outdoor member appreciation event. Additionally, the younger member committee was formed and held their first event as well. The annual NITE/ASCE Nebraska Chapter Transportation conference was held virtually this year due to the pandemic. Section activities and notification of members was done electronically through email as well as the Section's website. Meeting minutes for each of the meetings are available in the **Appendix**. Each of the events is described below, followed by a summary of the meetings in **Table 1**.

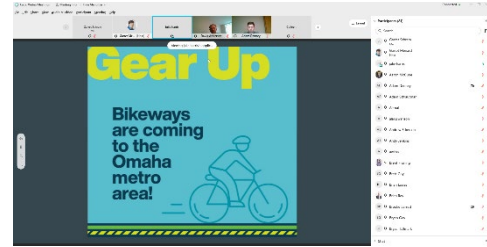


Figure 1 – Julie Harris presenting remotely at the February general meeting

- February 2021:** The first general meeting of the year was held virtually on February 24, 2021. The meeting featured Matt Kruse from Lamp Rynearson and Julie Harris from Bike Walk Nebraska (**Figure 1**), who gave a presentation on the Harney Street Bikeway Pilot Project. The presentation covered the various challenges and processes involved in the program. (81 attendees)

Also presenting at this meeting was Collen Agan from ITE. She gave an update on ITE and shared some information on how to get involved in the national organization.

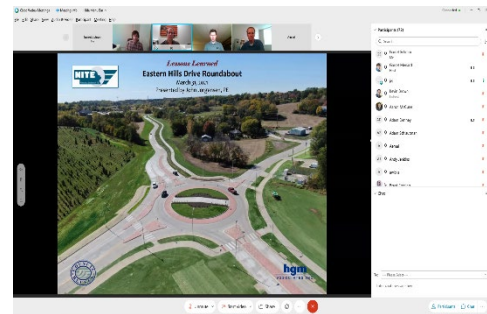


Figure 2 – John Jorgensen presenting on the Eastern Hills Roundabout

- March 2021:** The second general meeting was again held virtually on March 31, 2021. John Jorgensen from HGM (**Figure 2**) presented on the Eastern Hills Drive Roundabout Project. The intersection of Eastern Hills Dr and Greenview Rd presented some unique and challenging design and construction opportunities. John presented on those challenges and lessons learned. (72 members in attendance)

- May 2021:** Due to the ongoing pandemic, the annual NITE/ASCE Nebraska Chapter Transportation conference was scheduled to be held virtually over two days on May 28, and June 4, 2021. (**Figure 3**) Several speakers were featured discussing a range of topics from NDOT long range planning, Cities of Omaha and Lincoln signal retiming projects, UNMC and Crossroads redevelopment projects in Omaha. - July 2021:** The NITE Board hosted the seventh annual mini-golf member appreciation event at Boulder Creek in Omaha on July 15, 2021 (**Figure 4**). Members enjoyed snacks and beverages and two rounds of mini golf. (28 members in attendance)

- **September 2021:** The September general meeting marked the return to in person meetings for NITE. The meeting was held September 22, 2021 in Lincoln. Thomas Shafer from the City of Lincoln (**Figure 5**) presented an update on the Lincoln on the Move initiative. The presentation covered progress made so far, lessons learned along the way and future plans for Lincoln’s roadways and transportation system.(20 members in attendance)

- **October 2021:** The Younger Member Committee held its first event on October 19, 2021 at TopGolf in Omaha. (**Figure 6**). Younger members were able to network and enjoy food and beverages as they enjoyed some casual golf games.(18 members in attendance)

- **November 2021:** The Joint NITE/NSPE meeting was held on November 17, 2021 at the Scott Conference Center in Omaha. Mark Meisinger from Felsburg Holt & Ullevig and Jeff Johnston from NDOT presented on the I-76/I-80 Interchange project (**Figure 7**). The presentation discussed the IJR Study, design issues and considerations, and also an overview of construction progress and challenges faced during the process. (48 members in attendance)

- December 2021:** The first ever NITE annual meeting was held in person on December 15, 2021. The meeting included the end-of-year business meeting, a speaker, a look ahead to next year, and some games. The new board member, Kevin Brown, was announced and Garret Menard was honored as the departing Section President. The speaker was new NDOT Director John Selmer. He presented a 2021 year in review and 2022 preview for NDOT including plans for the recently passed federal transportation bill (**Figure 8**). DriveSmart

This project was initiated in 2008 after the MOVITE president challenged local chapters to find ways to “make a difference” in their communities. In response, NITE (formerly LOCATE) developed an outreach program to educate local area high school students regarding safe choices when driving. The goal of the program is to discuss safe driving choices with teens that are either beginning to drive or have just begun driving. By introducing these topics to drivers at a young age, we hope to help them form good driving habits and raise their awareness regarding the various consequences associated with poor choices behind the wheel.



At the end of 2015, this program became independent of the LOCATE/NITE organization. However, it is still primarily staffed and run by NITE members and receives sponsorship through NITE. The program is run and maintained by Brian Johnson and Jake Weiss. Brian organizes presentations and volunteers within Lincoln and Jake takes care of Omaha area presentations. Many schools remained shut down in early 2021 resulting in no in person presentations. As schools reopened in the fall the program was able to reach 836 students. Cumulatively since its inception, the DriveSmart Presentation has reached over 28,252 students.

As schools continue to return to in person classes in 2022 the program looks to get back to normal operations. They will continue to partner with the Buckle Up Phone Down campaign from NDOT that began in 2020. This program utilizes a video and virtual presentations that will allow the program to reach students in more areas outside of Lincoln/Omaha. There are also plans to update/refresh the presentation with up to date statistics and more relevant information.

Younger Member Committee

The NITE board, at the direction of ITE and with the goal of increasing participation from younger members, formed the Younger Member Committee. The first meeting was held on August 31, 2021 and was held virtually. During this meeting ideas and goals for the committee were first discussed. Also during this meeting, Tim Adams was assigned to be chair of the committee. Other committee members include Kelsey Heffner, Mark Friend, Lamees Al Ghamari, and David Le. The committee met and planned their first event, a social gathering at Top Golf in Omaha. As this committee continues to get going, the goals are to increase participation among younger members as well as increasing outreach with local university students. The plan moving forward is to hold events in both Omaha and Lincoln as well as getting involved with the student meet and greets as universities return to in person learning.

Board Activities

The Board of Director’s met four times in 2021 to coordinate a variety of things from Section activities to the NITE Section transition as well as getting the younger member committee started. Board meetings were conducted virtually in the interest of safety and convenience. Meeting minutes for each of the meetings are available in the **Appendix**. A summary of the meetings is shown in **Table 2**.

Leadership Transitions

The election for our 2022 Treasurer was held in late November of 2021. Two candidates vied for the position: Kevin Brown and Mark Friend. The candidate bios are included in the **Appendix**. This process was also administered through the election website, OpaVote. Private, electronic ballots were sent out to the membership and all voting was kept confidential. The cost to use the OpaVote voting system was \$10 for this election. Voter turnout was strong, with 53 returned ballots. Section Transition

The transition from a chapter to a section continued during the early part of 2021. The Board continued working to finalize details such as registering with the Nebraska secretary of state, obtaining 501 3(c) status, opening a new bank account, obtaining a new IRS EIN, and opening a new PayPal account. The completion of these activities was a large milestone in the transition from a chapter to a section.

Finances

In 2021, NITE operated a deficit for the first time in a few years in part due to not helping facilitate a MOVITE meeting this year. NITE was still able to continue its contributions to the following expenditures:

- Sponsorship of DriveSmart
- Contributions to the McCoy Scholarship Fund
- Free lunches for students attending general meetings
- Member Appreciation event
- Expenses related to the NITE website
- Miscellaneous meeting expenses

Annual dues and lunch costs charged to the members primarily covered the expenses related to general meetings and other operations of the Section, such as providing free meeting attendance (including meals) for students. 2021 member dues were \$17. The board again contributed to the existing Pat McCoy Scholarship fund. At the end of 2021, the Section's account balance was \$9301.91. The Board planned to reduce the account balance in 2021 by continuing to partially subsidize lunch fees at general meetings. Additionally, the board agreed on a larger expense for the kickoff of the Younger Member Committee by covering all expenses for the first event in order to help encourage attendance and get the committee off the ground. The final 2021 Treasurer's Report, listing total expenses, revenues, and reserves, is included in the **Appendix**.

With the 2021 financial information, anticipated future expenses and income were estimated to develop a NITE Section budget for 2022. The 2022 budget will be approved by the Board of Direction in early 2022 and is included in the **Appendix**.

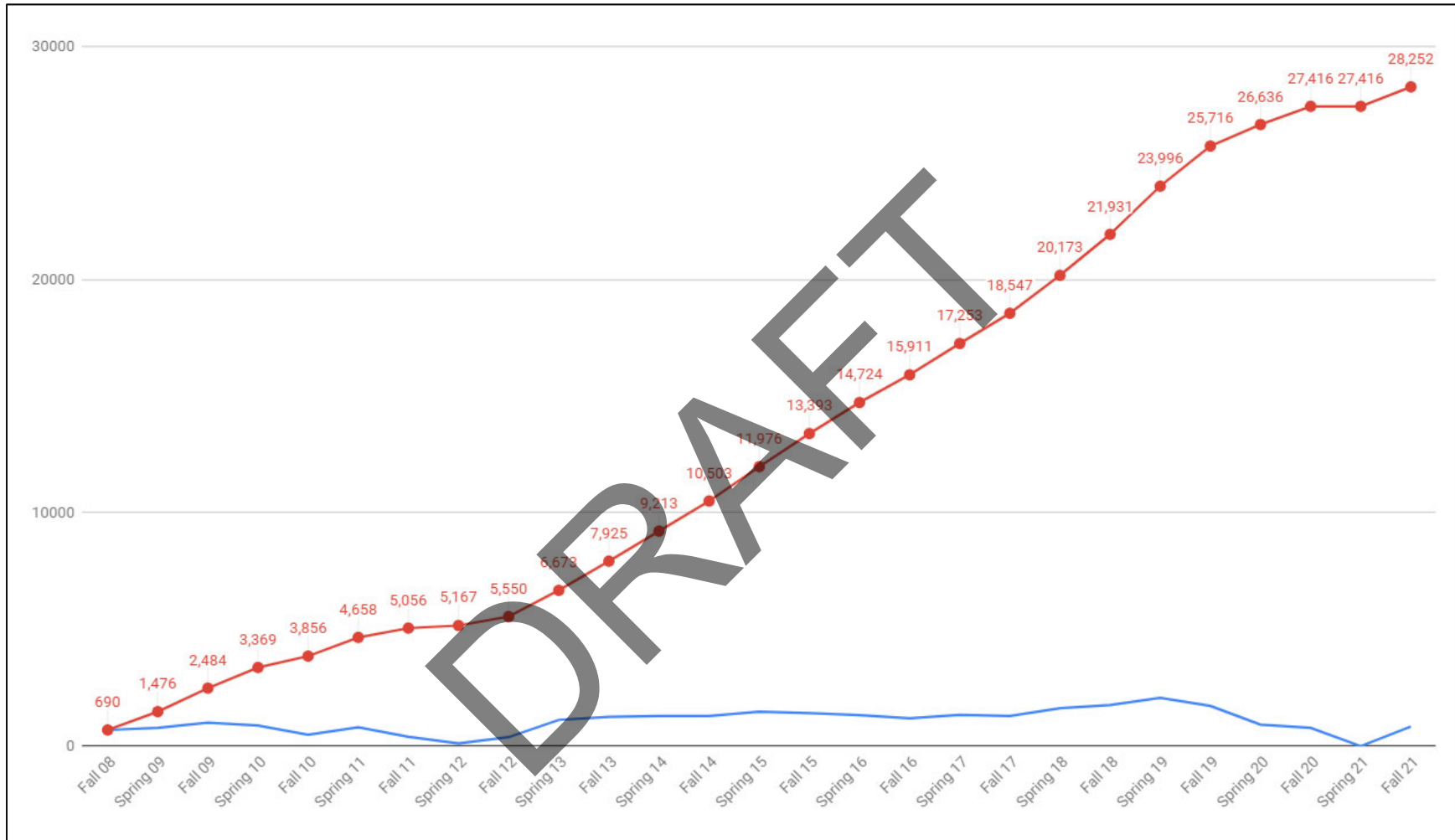

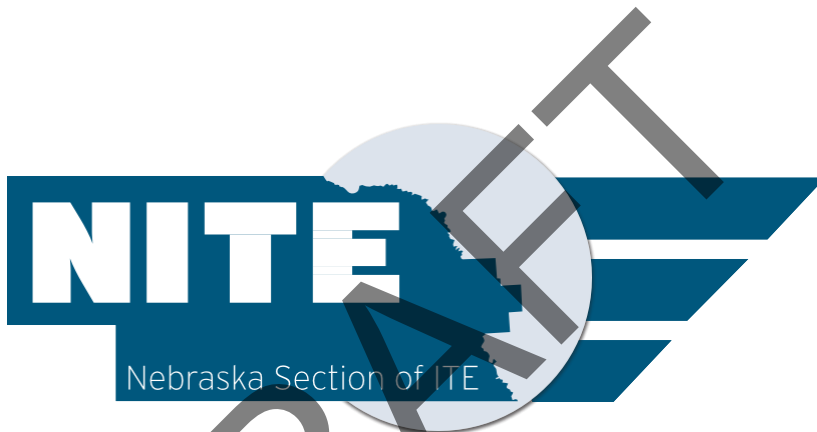
